Enrollment Fees.

- 1) All fees charged for the programme must be transacted at the information counter prior to the commencement of such programme and any cash payments to the Aquatic Educator directly is prohibited.
- 2) All fees paid are Non-Refundable.
- 3) Monthly programme fees must be paid on/or before the 1st week of each month, failing which the club & Aquatic Star Academy reserves the right to delete the name of the participant from the programme register and the participant will no longer be able to take part in the programme enrolled.

Termination Notice & Absenty Notice (forms are available from the club)

- 1) A participant may terminate by giving at least **one month's** notice in writing by filling up the termination form.
- Upon expiry of the one month notice, the participant's name will be deleted from the programme register and will no longer be able to continue with the lessons.
- 3) A participant may go on absent more then 2 weeks to a month by giving at least **one month's** notice in writing by filling up the absenteeism form.
- 4) The one month notice for absenteeism or termination will only take effect based on the date acknowledge by the club upon submission of the forms.

Liabilities.

- Neither the club, Aquatic Star Academy Sdn Bhd nor the Aquatic Educator will be held liable for any of the participant's personal
 injuries, death or inconvenience caused whatever or however caused to them while taking part in the programme.

Programme Schedule.

- The programme schedule may be altered at any time by the management at their absolute discretion and with/without prior notice.
- 2) The scheduled programmes will not be replaced should the participant fail to attend or due to bad weather.
- 3) There will be no lessons conducted on public holidays but the lesson will be considered as a class.
